This is How We Collect And Store Information

When you visit our website, it is like when you walk into a store. The sales person at the store may remember your face when you come back to the store. Similarly, your computer's IP address is like your computer's face, and when you visit our website, we receive information including your IP address, browser, dates and times of access, domain names, and websites that referred you here. Like the sales person in the store, we do not know your name or any other personal information about you unless you give us that information. When you submit your name, email address, or other information that identifies you as a person, we keep that confidential and do not share that with anyone else, except under the circumstances listed below.

Information That Identifies You as a Person

You may want to give us information that identifies you as a person, like your name, email address, address, or phone number, so that you may receive services or products from us. When you give us this information, we keep it, and we may also share it with payment companies like PayPal to process a payment for you. When you give us this information, we will not ask for your consent to share the information with a payment processing company, but we understand you have consented to that by asking to purchase services or products.
